

T&Cs – Promotion collect & get

FULL TERMS & CONDITIONS:

1. Promotion open to residents of The Netherlands, excluding employees and their families of Chiquita Europe B.V. (“the Promoter”), their agents or anyone else professionally connected with the administration of the promotion.
